Terms and Conditions:

By signing this agreement, competitors acknowledge that they understand the following terms and conditions of entering the championship. Note that these terms and conditions include individual responsibilities and requirements of representation imposed upon the winner of the championship.

1. The Winner of the Singapore National Barista Championship (SNBC) is a representative of the Singapore Coffee Association (SCA).
2. Upon entry in the Championship and in exchange for the opportunity to win the first prize, each entrant in the SNBC undertakes that they will:
 - a) Permit SCA to use the winner's name and image in any format without charge for the purpose of promotion of the SCA or the SNBC.
 - b) Without limiting the generality of clause (a), the formats referred to in clauses (a) may include: photographic, video, print, Internet or any electronic media.
 - c) When fulfilling these terms and conditions, actively work to uphold the good reputation of the SCA and SNBC.
 - d) Assist the SNBC sponsors in their marketing activities with the approval from SCA, where reasonable remuneration will be given.
3. Upon entry in the Championship and in exchange for the opportunity to win the first prize, each entrant in the SNBC undertakes that, should they win the SNBC, they will:
 - a) Be available to travel to Vienna Austria, to compete in the World Barista Championship from June 12 -15 2012.
 - b) Cover the miscellaneous costs while in Bogotá. SCA will provide airfares, accommodation and travel insurance.
 - c) Include the name "Singapore Coffee Association" or "SCA" immediately before the name "Singapore National Barista Championship" or "SNBC" in each instance, which the name "Singapore National Barista Championship" or "Singapore National Barista Champion" is mentioned.
 - d) Include the name "Singapore National Barista Championship" or "Singapore National Barista Champion" in each instance in which the name "World Barista Championship" or "World Barista Champion" is mentioned.
 - e) Without limiting the generality of clauses (c) or (d), the instances referred to in clauses (c) and (d) include mention verbally, in print or via any digital media.
 - f) Promote the Singapore Coffee Association at every opportunity without charge to SCA.
 - g) Promote the Singapore National Barista Championship as the only Singaporean pathway to the World Barista Championship at every opportunity without charge to SCA.
 - h) During the period of announcement of the 2012 SNBC winner until the announcement of the 2013 SNBC winner, perform such promotional or teaching tasks without charge to SCA.
 - i) Without limiting the generality of clauses (h), the tasks may refer to in clauses (h) may include: participation in media interviews, live appearances, writing of columns for the Association's website or newsletter, teaching or training.
